

The Club Secretary, Amber Allen, attended the event on the Club's behalf. Unfortunately, the Club did not win any awards this year, but it is always a great event and a great opportunity to hear about the achievements and initiatives going on in other sports across the University of Melbourne.

5 Committee of Management Reports

5.1 2024 President's Review – Gus Cirillo

Once again as I reflect on 2024, all I see are positive outcomes and opportunities that are waiting to be taken advantage of.

We saw the introduction of seven new junior teams following a year where our ability to continue to operate our junior academy was sadly taken away.

The club's high engagement in trial selection period continues to demonstrate that we are a strong "club of choice" for many athletes.

The club remains committed to providing best possible environment for club and team success. Although the club's goal is to support all teams with non-playing coaches, this is goal that still eludes us, yet our strong and committed player base continues to volunteer to fill our coaching gaps. Our committed group of coaches have done an outstanding job in preparing our teams for competition, realised by some wonderful performances and results.

In my opening remarks above I spoke of opportunities that we must take advantage of. This has to start with building relationships and partnerships with a range of stakeholders and supporters. Shifting our mindset from just being a sports club to being a thriving business that continues to focus on growth and member services. To this point, let me provide some examples:

- I can advise that the club is in discussion with an external junior volleyball Academy to establish a partnership that will benefit both parties in achieving mutual goals. More to come on this in early 2025;
- The club is in discussion with Volleyball Victoria in trying to secure another CBD training venue. If successful we would seek homes games, ability to grow our social competition, to grow our player development programs through both social and an academy structure;
- Success in gaining external sponsorship to ease member cost burden.

As I've mentioned above, we remain a strong "club of choice', and at presentation night I spoke about what that might look like from an external perspective. Here are my thoughts on this:

- Professionally run club in an amateur environment;
- Strong reputation and culture to work and train hard;
- An inclusive and enjoyable environment;
- Learning environment for personal growth;
- A club with opportunities to play;
- A successful club, not only in performance, but also in member satisfaction.

External perception is often regarded as reality, internally how do we achieve being the club of choice:

- Strong and progressive administration;
- Strong volunteer base with active members and not passive commuters;
- Strong financial and resourced club to make volleyball affordable and successful;
- Recognise and reward volunteer efforts appropriately;
- Socially active member base with events and programs that brings everyone together;

My final message is that we need to continue to have engaged members to meet the challenges of tomorrow.

Committee Performance & Structure

The club committee's work during the year appears to see no end, as you finish a season you begin to plan and prepare for the next. It's clear that without a strong administration as previous noted above, no organisation can succeed.



It's also clear that as the club faces new challenges from a range of external stakeholders, the club's ability to meet those challenges becomes more difficult without strong volunteer support, and awareness from members that their support, while at the club, is essential for success.

These challenges emanate from national, state and government bodies in an effort to align with community expectations of local sporting organisations. We know that in 2025 there will be additional regulatory requirements introduced to meet those community expectations.

I would like to thank every member who volunteered their time in whatever way to support the club, it is greatly appreciated.

Club Operations & Programs

Preparing the club for the year ahead is never easy and without a group of members that deal with the basic operational elements of fielding some 19 teams is a credit to those that raise their hands to help.

The club's program managers continue to successfully run our programs that delivery valuable rewards to all members. I cannot stress enough the importance of these programs, of which their grow is only limited by available venues.

I call upon members to contact the committee if even a whisper is heard of a new venue.

Club Finances

Whilst we did not see a downturn in participation, memberships and successful programs, the Club needs to broaden its revenue streams to ensure it can continue to provide members with financial support and keep fees as low as possible.

Clearly fundraising events is a major gap in the club's calendar that needs more focus.

In regards to the club's financial framework, the club will be working with Melbourne University Sports to provide the club with accounting support to deliver and more efficient accounting system and improved financial reporting as a result.

Coaches Program

With the growth in teams brings the struggle of finding coaches. To this point, I can't thank enough all our coaches that contributed to our on-court success. As all clubs have issues in supplying quality coaches, I trust that all teams appreciated the efforts of all coaches this year. I'm sure 2025 will bring its own challenges.

5.2 Vice President – Rosemary Bissett

I attended meetings for the MUS Club Advisory Group and the MUS Advisory Board in 2024.

The Club Advisory Group reviewed and discussed information on topics including the following during the year: Sport Leadership Award and Club Performance Awards nominations, UniSport Australia's Sport Sector Survey, MU Sport Precinct Refurbishment and the MU Sport Strategic Plan Update, and other issues as they may impact on clubs and other club updates/points of interest.

The MUS Advisory Board received presentations from a range of Clubs throughout the year and heard presentations and discussed matters including those related to the Strategic Plan for Sport, the Narrm Scholarship Program, and the MUS budget.

5.3 Treasurer – Anthony Williams

As mentioned above, the club will be undertaking a review of financial systems to align them with Consumer Affairs Victoria rules and its reporting threshold requirements.

In reviewing Australian Tax Office (ATO) rules the club has realised that the club has reached the GST registration threshold, and will require to register for GST. This requirement was back dated to the

2022 financial year, consequently, the club will be working towards GST registration in 2025 with a potential tax liability as a result.

As for 2024, the cost of living rose again, increasing costs for the club and in turn requiring increase in fees. There was a notable increase in Victorian Volleyball League (VVL) entry fees from 2023. Fortunately, this did not result in a reduction in participation, with all programmes filling to near-capacity. We managed to secure funds from several sponsors to go towards new training tops.

With no dedicated fundraising events in 2024, more work needs to be done in 2025 to deliver a greater cash surplus to further subsidise club membership fees where possible.

5.5 Club Coaching Program

Men's Program Report

Coaching Director - Gus Cirillo

The Men's coaching program was admirably supported by some very experienced non-playing coaches, as well as players that stepped up to take on a coaching role.

The trial period not only allowed the club to introduce new players across most teams, but it also allowed returning players an opportunity for well-deserved promotion. From this process the club remained strong in their participation in the Victorian Volleyball League by again entering six senior teams and four junior teams.

There were minimal issues that required attention, indicating that team harmony was great across the program. This led to players having a single focus of training and playing to the best of their ability, and not allowing any uncontrollable distractions impede their goals.

As noted in the summary results table above, the Men's teams had mixed success this year in terms of gold medals wins, however, a number of players across both Men's and Women's program were recognised for their individual efforts during the year.

I would like to acknowledge all coaching efforts during the year and hope that the club has offered enough inspiration and opportunities to return in 2025.

Women's Program Report

Coaching Director - Tanya McInerney

Due to the changing volleyball landscape, it was evident that the Women's Program would need to enter a rebuild stage. As some of last year's players were moving on, the doors opened for a large number of returning players to take the challenge that would place the club in a strong position for future success. Add to this a strong group of junior players that trialled in January, the junior presence at the Club is looking particularly strong for the future.

The club fielded six senior and three junior Victorian Volleyball League women's teams – finishing with 3 quarter finals losses and one silver medal in a year of major rebuilding.

From an individual coach's perspective each coach faced their own unique team goal for the season, some was to make it to finals, others to develop and provide opportunities for later success. With this in mind, some teams used the first half of our season to focus on skill development to provide solid base from which to attack the remaining of the season. With the fundamentals in place, this allows for a focus on team strategies as the season progressed.

The team dynamics during the year were robust and competitive at training and games across all teams. There was strong friendships and respect for each other and the coaching teams. Players were all extremely coachable and receptive to instruction and change, yet questioning with respect in mind. In some instance coaches and teams has to reset their goals to ensure everyone was on the same page, understanding that a professional approach is required when initial goals are not working.

5.6 Operations Managers – Lauren Albano and Jonathan Dunlop

Managing operational facets of the club to ensure that all teams establish a line of communication with the committee to deliver a seamless playing experience is the essence of these roles.



Ensuring teams are equipped with the necessary tools to train and play volleyball should be an easy task, however it's not, with uniform stocks being the major issue from the beginning of the year. The reality of player movement in and out of the club makes for securing enough uniforms extremely difficult, when supply of new gear could take 4-6 weeks.

Teams are expected to elect a team manager to communicate club policies on operational and financial responsibilities of each team. It is with these team managers that we work and support to run an efficient process.

5.7 Social Events – Amber Allen and Clare McIlveen

In the absence of an elected social sub-committee, other committee members stepped up throughout the year to organise and deliver a successful Pub Crawl and end of year Presentation Night.

5.8 VVL Club Delegate – Clare McIlveen

The main role for the 2024 season was ensuring all transfers both in and out of the Club were approved as well as the ongoing liaison with Volleyball Victoria throughout the season. The 2024 VVL Season saw many new features including the addition of the Junior Premier League, Youth State League moving to Friday nights and crossover pools for the Premier League. The club was pleased to have entered every division with a total of 19 teams entered, including five junior teams highlighting the depth within the club and the emerging pathways available for players.

5.9 Melbourne University Sport Liaison Officer – Alex Bye

The essential element of this role is to liaise with Melbourn University Sport in relation to intercollegiate, intervarsity sports and campus open days during each semester to engage with new students to communicate the volleyball opportunities as part of their University of Melbourne experiences.

5.10 Junior Development Officer – Karl Hayduk

At the start of the season, we had over 60 girls and boys registered to be part of the U17 junior state league trials for 2024.

We had some returning players from 2023 and some moved on to be part of the U19 premier league teams; while some just moved on to pursue other interests. We also had players that were part of the junior development program in 2023 trying out and succeeding in making it into a team.

We also had strong numbers of participants in our junior development (training only) program which included boys and girls not wanting or not ready to play state league.

For State League this year, the club was well represented in the Victorian U/17 State League run on Friday nights, having a total of three boys' teams and two girls' teams. This number exceeded all expectations!

Two boys' teams and one girls team trained at Melbourne Uni. The other boys' and girls' teams trained at Ivanhoe.

With a fantastic coaching team three of the teams made it to the final series playoffs.

Some of our team members were selected for the Victorian Volleyball Squad and represented the State in the Australian Youth Volleyball Championships in Bendigo.

As a Club (some of us being involved for over 40 years) our broader commitment is to the sport of Volleyball as a whole. We aim to encourage and develop players of varying skill levels to get involved in both the social and competitive aspects of the sport.

The year produced many highlights, and although players will have their own stories to tell, from my perspective the biggest highlight of the season was not in the achievements of individual players. It was the way that the individuals came together as a unit. Players and parents supported each other every



step of the way, from timely words of encouragement, to driving each other to the games. They were committed to consistently attending training, something as coaches we know is vital to the success of any team.

Overall, I was impressed with our players, they took their volleyball seriously but still had a lot of fun along the way!

Moving forward the club will be faced with fresh challenges not experienced in recent times with the junior program, that is, things like:

- Load management (most athletes are in multiple programs, how do coaches not burn them out?)
- Balancing school homework/volleyball commitments (how do we manage training times?)
- How to introduce, manage and involve say 20-30 new U17 players and their families every year
- What is the future pathway for juniors?
- 5 x U17 teams reduce to 2 x u/19 teams. Where do they play?

Looking back over the year it has been a very rewarding one for all.

5.11 Mixed Development Training Program – Jules Ng

This program continues to develop players to prepare them for selection and competition. It's an excellent ground for our University of Melbourne students to participate in their choice of sport, but necessarily in a competitive environment. Below is a short summary of the year:

- 3 courts; 6 coaches; 140 players per week
- Implemented new booking system to improve player and coach experience
- Massive turnout of both new and returning players
- Thanks to our coaches Simon Meiri, Alvin Ip, Jonathan Feng, Javen Ow, Jerry Dang, Ziyue Yin, Gianna Fermo

5.12 Tin Alley Competition – Ryan Bruysters

Once again, this program remains an integral ingredient to our financial stability. Without strong support and participation in this program, club membership fee would not be at the levels they currently sit.

- 2 x 16-week competitions; one per semester.
- 3 divisions
- 52 new teams registered in semester 1; 15 new teams registered in semester 2.

5.13 Social Media – Laura Pangrazio

In 2024, we focused on increasing the quality of our content and experimented with outsourcing photography and graphic design. This was successful as we were able to create a group chat with Renegades photographers, graphic designers and videographers who provided the Club with a consistent flow of content. We also accepted more Instagram collaborations with content creators external to the club who shared their content with us for free. Our Instagram following and engagement grew significantly, and we were able to reach more people than previous years. This growth provided a foundation for our new marketing focus in regards to creating high quality content and contributing to growing the love for the sport and the league online. We aim to continue this growth by running a media day, posting more hype videos and providing more personal and 'behind-the-scenes' content of the Club and its athletes.

As is common for organisations of this type, it is not practical for the Association to maintain an effective system of internal control over the income and expenditure activities until their initial entry in the accounting records. Accordingly, our audit in relation to these income and expenditure amounts was limited to amounts recorded.

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of Melbourne University Renegades Volleyball Club Inc. in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 Code of Ethics for Professional Accountants (including Independence Standards) (the Code) that are relevant to our audit of the financial report in Australia, and we have fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter - - Basis of Accounting and Restriction on Distribution and Use

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report is prepared to assist the Melbourne University Renegades Volleyball Club Inc. in complying with the financial reporting provisions of the *Associations Incorporation Reform Act (VIC) 2012*. As a result, the financial report may not be suitable for another purpose. Our report is intended solely for the Melbourne University Renegades Volleyball Club Inc. and should not be distributed to or used by parties other than the Melbourne University Renegades Volleyball Club Inc. Our opinion is not modified in respect of this matter.

Committee's Responsibility for the Financial Report

The committee of the association are responsible for the preparation and fair presentation of the financial report and have determined that the accounting policies described in Note 1 to the financial statements, which form part of the financial report are consistent with the financial requirements of the *Associations Incorporation Reform Act (VIC) 2012* and appropriate to meet the needs of the members. The committee' responsibility also includes establishing and maintaining internal controls relevant to the preparation and fair presentation of the financial report that is free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

In preparing the financial report, management is responsible for assessing the Melbourne University Renegades Volleyball Club Inc's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless management either intends to liquidate the Melbourne University Renegades Volleyball Club Inc. or to cease operations, or has no realistic alternative but to do so. Those charged with governance are responsible for overseeing the Melbourne University Renegades Volleyball Club Inc's financial reporting process.





Auditor's Responsibilities for the Audit of the Financial Report

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.

Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

As part of an audit in accordance with Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to audit in order to design audit procedures that are
 appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the
 association's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the association's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial report or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the association to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

Independence

In conducting our audit, we have complied with the independence requirements of Australian professional ethical pronouncements.
